- 01. All laws and game regulations will be strictly adhered to.
02. Each hunter must show a valid hunting license and sign the log books before the hunt commences.
03. All game must be properly tagged by the hunter and reported to the guide.
04. There will be absolutely NO drinking during the hunt. Guns, drugs, and alcohol don't mix when the hunt is on...EVER.
05. If a situation occurs where a hunter is requested to leave, there will be no refund of money to that hunter.
06. To save time, have your gun sighted in before you arrive.
07. All guns will be stored at a designated place at camp.
08. At the end of the hunt, all meat and capes will be removed.
09. Help us keep your blinds and camp clean. Pick up after yourself.
10. For your convenience, DAN MOODY HUNTING SERVICE will collect a deposit and deliver your trophy to a local taxidermist.
11. For your convenience, DAN MOODY HUNTING SERVICE will drop off your meat to be processed at local processing plants.
12. If the hunt has to be cancelled due to bad weather, act of nature or an accident that will affect the hunt, no money will be refunded.
